

The Boston Pearl Foundation, Incorporated was established in August 2005 by the members of the Psi Omega chapter of Alpha Kappa Alpha Sorority, Incorporated as a vehicle to expand the scope of scholarly assistance and community enrichment available in the Boston area. Our mission is to:

- advance education by offering financial assistance to underserved students, with a specific focus on supporting minority freshmen enrolling in four-year colleges and universities
- support charitable community programs in the Greater Boston area, with a focus on initiatives that enhance health, social well-being, and awareness of issues affecting local neighborhoods

### LEGACY OF SERVICE



Psi Omega Chapter supports college-bound students from Greater Boston by awarding scholarships to graduating high school seniors pursuing higher education. Since presenting its first \$75 scholarship in 1932, the Chapter has awarded over \$300,000 to deserving students.



Committed to supporting community elders, Psi Omega Chapter has collaborated with the Edgar P. Benjamin Healthcare Center (Roxbury, MA), where it has renovated and dedicated two residential rooms. Members also volunteered monthly and provided seasonal gift baskets to residents.

The Chapter leads initiatives addressing critical health and economic issues in Boston communities. Members actively participate in annual walk-a-thons to raise funds for causes such as hunger, cancer, and AIDS. Additionally, Psi Omega Chapter has supported national initiatives, including Sickle Cell Anemia Research, the Sudden Infant Death Syndrome Alliance, and an African Village Development Program.



## **PRECIOUS PEARLS DEBUTANTE PROGRAM**

The Precious Pearls Debutante Program, a partnership between the Psi Omega Chapter of Alpha Kappa Alpha Sorority, Inc. and the Boston Pearl Foundation, Inc, is dedicated to fostering the growth of young women through mentorship, educational services, and community engagement.

The Cotillion serves as the grand finale, celebrating the culmination of six months of cultural, educational, and community service activities, as young women are introduced to society by their parents or guardians.



For over 35 years, the Psi Omega Chapter has been supporting debutante programs in Boston, with the first program launched in 1973. Like other youth development initiatives offered by the chapter, this program provides education, mentoring, and positive growth opportunities. In collaboration with the Boston Pearl Foundation, Inc., the Debutante Program specifically targets young women of color in grades 9-12.

In today's media landscape, where portrayals of women can often be negative, the Precious Pearls Debutante Program offers young minority women in Greater Boston a positive self-image, access to role models, and personal development opportunities that emphasize high moral and ethical standards. This six-month program culminates in a formal ball that celebrates the debutantes' journey toward becoming culturally refined, confident, principled, and community-oriented women.
